


Introduction

The purpose of the Workforce Training Fund is to provide resources to Massachusetts' businesses and workers to train current and newly hired employees, supporting businesses' productivity and competitiveness. On behalf of the Executive Office of Labor and Workforce Development, Commonwealth Corporation administers the Workforce Training Fund Program that is funded through an assessment on Massachusetts' employers' Unemployment Insurance contributions.

The enabling legislation for the Workforce Training Fund (Massachusetts General Laws Chapter 29 Section 2RR) calls for a report to be filed with the Joint Committee on Labor and Workforce Development and the House and Senate Ways and Means Committees, by September 1 of each year. The report addresses grants made during the previous fiscal year together with such recommendations and additional information as considered appropriate.

The report must also include information concerning the collection of the workforce training contributions for the previous calendar year including (i) the amount collected in each quarter and the total amount collected for the calendar year; (ii) the total number of employers that contributed to the fund and the total number of employees employed by that group of employers; and (iii) the contribution rate.





Workforce Training Fund Grant Programs

During Fiscal Year 2022 (July 2020 – June 2021), the Workforce Training Fund Program offered two different grant programs to Massachusetts businesses to upskill incumbent workers. These grants support skills acquisition for thousands of workers and improving the competitiveness and productivity of hundreds of businesses across the Commonwealth.

GENERAL PROGRAM TRAINING GRANT

Businesses of any size are eligible to apply. (Intermediaries may lead a consortium application.) They may request up to \$250,000 for up to two years to support training for their workforce. Grant funds must be matched dollar-for-dollar. The match may be cash or in-kind (including wages paid to employees during training).

EXPRESS PROGRAM GRANT

Businesses of any size are eligible to apply for grants to cover training selected from a database of registered courses. Businesses may receive up to \$30,000 per calendar year; the maximum payment per trainee, per course is \$3,000.

For grant recipients with more than 100 MA employees, upon completion of an approved course, you may receive reimbursement of as much as half the total cost of training, up to \$3,000/person/course.

For grant recipients with 100 or fewer MA employees, upon completion of an approved course, you may receive full reimbursement of the cost of training, up to \$3,000/person/course.

2022 Highlights

FY22 represented a period of unprecedented growth in engagement with an emphasis on access for small and diverse businesses. Since the onset of the global COVID-19 pandemic, the Workforce Training Fund has pivoted to directly address the needs of small and diverse businesses that have been disproportionately impacted by the pandemic. During FY22 82 % of the grants awarded went to businesses with fewer than 100 employees. The largest growth segment includes businesses with 10 or fewer employees. In FY22, 527 grants were awarded to these businesses, which is more than four times the number of grants awarded to this segment in the prior year.

As a result of policy changes, increased investment customer support staff, and increased investment in technology to improve user experience, we have improved the value proposition for small businesses in the Express Program. Workforce Training Fund Programs have also made additional investment in outreach and marketing to minority-owned and women-owned enterprises and will continue the focus on diverse business engagement and businesses located in gateway cities during FY23.



Grants Awarded In 2022

During FY22, 2,242 new training grants totaling \$31,646,866 were awarded by the Workforce Training Fund Programs, including grants from the General Program and Express Program. During FY22 the Workforce Training Fund Programs engaged 1,338 businesses, which represents an 80% increase over the 742 businesses engaged during FY21.

FY22 General Program Training Grant Awards

In FY22, Commonwealth Corporation awarded 141 General Program Training Grants involving 165 businesses. This includes 6 consortium grants partnership projects involving 30 businesses. The total amount awarded was \$18,401,028. In total, the businesses plan to train 9,961 workers with these funds. The businesses project that by the end of their two-year grant periods they will have a net increase of 3,699 additional workers employed in Massachusetts.

FY22 Express Program Grant Awards

In FY22, Commonwealth Corporation approved 2,101 grant applications from 1,173 unique businesses for a total of \$13,245,838 in grant funds to train 13,379 employees. (Note: Businesses may submit multiple applications; employees may participate in multiple courses.)


Impact Analysis

WTFP GENERAL PROGRAMS GRANTS CLOSED IN FY22

General Program Training Grants Completed in FY22

In FY22, 101 General Program Training Grants closed after completing two-year training initiatives. In total, the 101 grantees projected adding 1,212 workers by the end of the two-year grants. The actual number of net new jobs added by the end of their grant period was 872, which is only 72 percent of proposed job growth. Overall, the grant recipients reported 5.4 percent employment growth over their two-year grant period compared to 15.9 percent statewide, and 11.4 percent nationally.

Typically, businesses completing General Program Training Grants experience significantly higher growth rates than state or national averages. FY22 is a notable exception. Most grants ending during FY22 were initiated prior to the COVID-19 pandemic. As a result of the pandemic, training has been scaled back and/or extended beyond original timelines and larger economic trends have impacted net job growth.



Businesses in the Manufacturing industry made up the largest share (52 of 101) of the General Program Training Grants that ended during FY22. The next largest industry sector was Professional, Scientific and Technical Services, followed by Finance & Insurance.

Of the 101 grantees to complete training in FY22, 54 (53 percent) reported an increase in their Massachusetts workforce since the beginning of their grant period. Eleven (11 percent) reported their employment levels remained unchanged and 36 (36 percent) reported they had fewer employees at the end of the grant period.

The original amount awarded to the 101 grantees totaled \$8,728,105; the final amount expended at the end of the grant period was \$5,853,973 (67 percent of the amount awarded). Only 26 percent of grantees expended their full contract amount. 74 percent of

grantees were unable to complete all training planned and therefore did not exhaust

awarded funds.

In total, the 101 grantees planned to train 7,347 employees; the actual number of trainees reported was 6,810 (93 percent of planned). 58 percent of grantees trained as many workers as planned or more. 42 percent did not train as many workers as originally planned.

General Program Training Grants Withdrawn in FY22

In FY22, 56 businesses that had been awarded General Program Training grants elected to withdraw from the program prior to completing training. These grantees requested a total of \$6,734,441 in General Program grant funds but used only \$1,727,397 (26 percent) prior to withdrawing due to unanticipated circumstances that resulted in cancelation of training. Unused funds will be reprogrammed for future grants.



Annual Collections of Workforce Training Fund Contributions

For the calendar year January 1, 2021 - December 31, 2021, a total of 233,431 employers contributed to the fund. These employers employed a collective total of 4,579,695 employees* for the same period.

The following chart shows the amount collected in each quarter and the total amount collected for the calendar year. The actual contribution rate is 0.056%.
